4. First aid measures

EYES: Irrigate copiously with clean, fresh water for at least 15 minutes.

GENERAL INFORMATION

6. Accidental release measures

PERSONAL PRECAUTIONS

Eliminate all sources of ignition (cigarettes, flames, sparks, etc.) from the leakage site. If there are no contraindications, spray solid products with water to prevent the formation of dust. Use breathing equipment if fumes or powders are released into the air. Block the leakage if there is no hazard. Do not handle damaged containers or the leaked product before donning appropriate protective gear. 10. Stability and reactivity

The product is stable in normal conditions of use and storage. Due to thermal decomposition or in the event of a fire vapours may be produced potentially dangerous to health.

Propylene glycol: it is hygroscopic, stable at normal conditions; at high temperatures, it tends to oxidize yielding propionaldehyde as well as lactic and acetic acid.

11. Toxicological information

According to currently available data, this product has not yet produced health damages. Anyway, it must be handled according to good industrial practices.

12. Ecological information

Non-aromatic mineral white spirits tends to be distributed exclusively in the air where it is photodegradable. The small amount that remains in the water tends to deposit at the bottom and is biodegraded; it is thus not bioaccumulated by fish. In the soil the substance remains absorbed and is unable to reach the subterranean layers.
